


Terms and Conditions for the Takata Airbag Recall Windscreen sticker Contest

1. The Contest is open to residents of Malaysia aged 18 years or over except employees of Mitsubishi Motors Malaysia Sdn Bhd and their close relatives and anyone otherwise connected with the organisation or picking of the winner(s).
2. By entering this Contest, the participant is indicating his/her agreement to be bound by these Terms and Conditions.
3. The Mechanics of the Contest and how to enter are as follows:
 - a. Get your car sticker at the nearest Mitsubishi Motors Malaysia authorized dealer.
 - b. Paste it on your windscreen or side window.
